

MESSAGE FROM THE PRESIDENT



Dixon Park's 2020 - 2021 Season was shaped by uncertainty across the globe and the many successes due to the work of our volunteers. Guided by the spirit of those young men who established a footprint on the beach in 1932, Dixon Park Surf Life Saving Club inc continues to SAVE LIVES, CREATE BETTER AUSTRALIANS AND BUILD BETTER COMMUNITIES.

What is certain, is the volunteering spirit that exists within the Club. Members both new and existing rallied to engage in what they love. That is, to give to their community, in way of nearly 3000 patrolling hours and many more hours supporting the operations of the Club. Significant funds were made available from the Club Lifesaving Equipment Grant, the Beach Safety Equipment Fund, the Small Business Grant, the Surf Club Support package, the Return to Sports Grant and the City of Newcastle.

We can proudly state that 'no lives were lost' whilst Dixon Park beach was patrolled. The season has been very successful and rewarding for the Club in all dimensions; culturally, lifesaving, education, nippers, surf sports, functions, administration, finance, community and socially. My thanks and appreciation to our members who were involved in and contributed to patrols and lifesaving services, education and training, nipper development and organisation, coaching and the numerous and varied functions of the Club. Without your selfless contribution, the Club could not meet its core responsibilities and have had such a great season.



Toni O'Donoghue, Director of Life Saving, coordinated the 10 patrol teams that volunteered their time and skills to support the beach-going community each weekend and public holiday during the season. A new IRB hull and motor were commissioned during the season and saw action straight away in the rescue on a nearby vessel. These items were funded by the Beach Safety Equipment Fund and the Club Lifesaving Equipment Grant. A new SBS (side-by-

side) all-terrain vehicle was also secured during this time. Continuing support from Port Waratah Coal Services is greatly appreciated. This partnership enables essential pieces of equipment to be made available to support the community.

Along with the other Clubs in the Branch, Dixon Park participated in the new Bronze Medallion and Surf Rescue Certificate courses which saw a revised curriculum, with an online component as well as modified assessment criteria. This program was led by **Stuart Barnett**, Assessor and Trainer. Whilst the experience was very different to previous years the courses ran smoothly and our candidates were successful at their assessment. As a result, we have the benefit of more qualified lifesavers which in turn improves our Patrol strength.

This season the Club also dealt with Patrol, Award and Junior Activity proficiencies, carrying out and processing 280 proficiencies prior to Christmas 2020. The Junior Activities section of the Club also offered and completed the relevant Surf Aware, Surf Play, Surf Safe and Surf Smart awards for the Nippers.

Our Surf Sports competitors were looking forward to capping off the season with the Aussies 2021. All Aussies' competitors managed to find their way to the podium. The Masters boaties with a Gold, **Paul Brady** a Silver medal in the beach sprint and **Peter Brown** with a Bronze in the surfing. The Masters Boat crew continues to be dominant at all levels of competition, Branch, State, Aussies and the Streets series. Thank you to **Peter Wilkinson**, Director of Surf Sport, for his work in encouraging all members of the Club to participate in a range of surf life-saving activities. All of which, go to develop the skills of the individual and the community culture of the Club.

The Club is very appreciative of the generous support it receives from its sponsors – **Hunter Civilab, Atwea College, Piggott's Pharmacy, QOH Architects, Vogue Residential, Frame Promotional Products and Port Waratah Coal Services**. I would refer you to the Thank You to Sponsors

section of this Annual Report. These funds are invested directly back into the services and activities of the Club for benefit of members and the community.

The 'business' of surf lifesaving which was already immersed in a world of compliance is now working through a host of recommendations that will allow clubs to function in the COVID-19 world. The members can be confident in the Club's governance and management processes. Executive members meet regularly to monitor the various dimensions of the Club that are directed to addressing our vision "to save lives, create better Australians and build better communities." On behalf of the members, we thank the members of the Executive Committee and the Junior Committee for their dedication, expertise, and generous contribution to the Club. I would also thank the team at Hunter Surf Life Saving for their ongoing support and advice to the Club.

We continue to strengthen our governance and management as a foundation for development, growth, and sustainability. This is evident through ongoing changes and enhancements to our administration, systems, and processes.

Conversations with the City of Newcastle continue. The goal is to identify a model that is supportive of surf lifesaving and the community, as we move towards our 100 years of service and beyond.

health challenges. Sessions are held at sunrise across the globe. People are allowed to come together in silence, appreciate and welcome the rising sun and the beginning of a new day.



Dixon Park was also recognised with the President's Award. Henry Scruton, the President of Hunter Branch Surf Life Saving, provided a commentary highlighting the challenges and the successes of Dixon Park during the COVID-19 2020 - 2021 season. It was with great pleasure that I accepted this recognition. Ben Parsons, our Director of Junior Activities, also provided significant leadership to a group of enthusiastic first-time nipper parents in a very uncertain (COVID-19) nipper season. ADMINISTRATION REPORT

The 2020 – 2021 Season presented an opportunity for many new starts. Patrols, competitions, education and training, and nippers all formulated new ways of delivering services. COVID-19 placed restrictions on all dimensions of surf lifesaving and as the season transpired this became ingrained into daily practise.

The Club is highly appreciative of the various grants that have supported lifesaving activities. The Surf Club Support Package was used to provide discount membership fees for active members for the 2020 season and to subsidise the Club's Annual Presentation Evening. The Club Lifesaving Equipment Grant (CLEG) contributed significantly to the purchase of an IRB motor. Small Business Grant assisted in upgrading equipment to facilitate more efficient contactless payments. The Beach Safety Equipment Fund (BSEF) was used to replace fuel cells for the IRB and purchase 2 rescue boards for patrols. The City of Newcastle's funding was used to purchase materials that were used for the completion of the hoist cradle. A project that was designed and supervised by Richard McWhinney. The new side-by-side vehicle was funded by Port Waratah Coal Services and Surf Life Saving Australia.

During the season Dixon Park took possession of its second mobile rescue board trolley. These trolleys were funded by the NSW Government and were custom made to allow for the movement of boards into and out of the Club.

Behind the scenes, activities like contact lists, call-out teams, equipment checks, financial monitoring and communication processes have all contributed to another successful year for Dixon Park. Addressing these mandatory compliance obligations enables the Club to participate in the process of securing grants. Dixon Park is one of 314 incorporate surf lifesaving clubs across the country. Many of these clubs and other organisations are actively seeking financial assistance for their projects. Our level of

compliance has significantly contributed to our success in securing financial support.

The Executive groups meets on a regular basis to monitor and guide the Club. This is an area that continues to seek a greater representation from members. All Executive members have contributed significantly to grow and strengthen the many dimensions of your Club.

Recently Deceased Members

Dale Lavery



Members were saddened by the sudden passing of Dale on Friday 30 October 2020.

Dale is remembered as a true stalwart of Dixon Park Surf Club, making his mark as a regular competitor in boards and skis. He joined Dixon Park as a Nipper in 1966 and gained his Bronze in 1976. He was always a successful competitor, with multiple Gold Medallist at Branch level with back-to-back double ski titles in 1987 and 1988. Dale was also a very successful Masters' competitor from 1994 – 2006, winning a swag of medals across a variety of disciplines.

Dale's leadership in developing and maintaining the Board and Ski section of the Club for many years was significant in its smooth running. This involved procuring equipment for member's use and the management of the Boat Shed area and most importantly encouraging our paddling members into Patrol activities.

Dave Ringland - Life Member and President



'Ringers' otherwise known as Dave Ringland passed away at the end of December 2020. A true local. Born into this world at Hillcrest Maternity Hospital, Merewether in 1943. Childhood in Merewether, which included school, exploring, sport and the beach. A career in education where again, school, exploring, sport and the beach were dominant. Ringers was a Life Member of Dixon Park SLSC and also held the position of President for 19 years, from 1989 to 2008. During this period, Dixon Park moved through many phases. The Club developed a very formidable Masters Team, of which Ringers was a member. Throughout the 1990s and into the new century this Masters Team claimed many titles. Including 1st NSW Masters Team competition in 2000. Dave's talent was on the sand. He claimed numerous medals in the areas of Beach Flags, Beach Sprint and Beach Relays.

During his time as the President of Dixon Park, the Club experienced many of the ebbs and flows, because of the increasing demands placed on volunteer organisations and the changing nature of the 'Club scene'. His strong sense of achievement and involvement assisted him in guiding the Club from 1989 to 2008. 19 Years as President! In 2000 Dave was recognised by Hunter Surf Life Saving for his contributions to Surf Life Saving.

John Tongue - Life Member and President



John passed away in February 2021 aged 82 years. He gained a bronze medallion in 1952 and held several positions on the committee including President and Club Captain. He was an active carnival competitor. John was a highly respected and dedicated lifesaver with a great sense of humour. He was a mentor to younger members for many years. He was awarded Life Membership for his services to the Club in 1985 and maintained a strong connection to the surf lifesaving movement in an advisory capacity over his later years.

Richard McWhinney - Life Member



Richard unexpectedly experienced a medical episode at Dixon Park on Wednesday 7 April 2021 and passed away the following day. At the time, Richard, Ross Burgess and Adrian Parker were putting the finishing touches on another of Richard's projects.

Completing a Bronze Medallion in 2001 and then a host of qualifications including Silver Medallion Patrol Captain, Silver Medallion IRD Driver and a Training Officer qualification for the Bronze Medallion and IRB Driver. He completed many years of service to the community as a volunteer lifesaver. His gifts included a clever analytical mind. Which allowed for significant innovation in the surf lifesaving area. Plus, and more importantly, was his ability to connect with people, engage with them, and pass on both the skills and the understanding of what it is to be a surf lifesaver.

Brett Norris - Life Member



Brett obtained a Bronze Medallion in 1982 and soon found his way into the IRBs with an IRB Crew qualification followed by a Silver Medallion IRB Driver, Advanced Resuscitation Certificate, Training qualifications and a Silver Medallion for Beach Management. His many years of service to the community was recognised with 25 years of service award in 2009. Brett contributed many hours, beyond rostered patrols, mentoring newer members in the ways of the IRB. These members developed their skills and knowledge through practice in the surf environment and negotiating the Dixon Park shore dump.

Brett and his father, Peter, both Life Members of Dixon Park have contributed significantly to our Club and the community. The Norris family connection with Dixon Park is approaching a significant milestone of 70 years. Brett's early years were clearly influenced by the family's belief in volunteering for the benefit of the community.


Our First President is Honoured

John (Jack) O'Reilly



Jack was the foundation President of Dixon Park in 1932 and soon found his way into other leadership positions. In 1937 he was a member of the Board of Examiners. His involvement in the growing surf life-saving movement was recognised with a Life Membership nomination to Australian Surf Life Saving. In 2021 the national body, Australian Surf Life Saving recognised its Life Members with a uniquely numbered patrol cap. This patrol cap with the number 110 was presented to Dixon Park at the Hunter Branch meeting in March. The number 110 represents the 110th person to be awarded the Life Membership status within the Australian Surf Life Saving organisation.

Frank Okulich - Australian Ski Gold Medal 1951



Shark kills ski champion

Frank a Dixon Park Club member who won the Australian Ski Championship at Scarborough WA in 1951. Frank also finished 2nd in the NSW Titles in 1950. In the early 1950s, Dixon Park had established itself as one of the leading clubs in Australia in ski events. Bill McIntosh, also from Dixon Park, won the Australian Single Ski Championship in 1950 and again in 1953. Frank was the 1951 Ski Champion. Frank did not get a chance to defend his title in 1952. He was killed by a shark at neighbouring Merewether Beach while body surfing with friends.

Mr John Glase, a family member from Sydney came into possession of Frank's 1951 Gold medal. John was in Newcastle recently researching the family history and made contact with the Club during his research. Frank's parents immigrated from Russia after the 2nd World War and lived in Rose Street Merewether. Frank is buried in Sandgate Cemetery alongside his parents.

John decided that Frank's 1951 Gold Medal should return to the Club and has generously donated it to join other valued memorabilia. 2021 marks the 70th anniversary of Frank's passing.

The Club wishes to express its sincere thanks to John for his generosity.

FINANCE REPORT

The Board is pleased to report a net operating profit of \$117K for the current financial year, and a cash reserve of \$534K, a result that was unexpected at the start of the year.

The Club entered this year affected by the Covid 19 Pandemic. Club activity re-commenced in October 2020 under restricted operating conditions. As restrictions were eased over the ensuing months, the use of the hall and bar has been in significantly higher demand than usual, continuing into the last quarter which is usually a quieter period for fundraising.

In addition, the Club has received direct financial support from all levels of Government and the SLSA, contributing significantly to the overall result.

The underlying profit from operations is about \$100k after considering the abnormal operating income and expenditure referred to above.

The result has allowed the Board to re-invest in,

- Some new tables upstairs,
- additional gym equipment,
- upgrade the beer system at the Bar.
- purchase a new 1000 litre fridge for the kitchen,
- Point of Sale system for the bar till,

The Club expresses its thanks to its staff, particularly Mikhaila Aubrey for her skill and enthusiasm in venue operations.

Special thanks go to our Bookkeeper Alison Wooden, who provides bookkeeping skills and financial assistance far beyond her job description.

LIFE SAVING REPORT

Our surf club does not exist without our patrolling members, so these volunteers who turn up every weekend and public holiday during the season truly are the life blood of our Club. The generosity of our patrolling members who give freely of their time and expertise allows Dixon Park Surf Life Saving Club to fulfil the SLSA mission of 'saving lives, creating great Australians and building better communities'.

The 2020 - 2021 season saw us commencing patrols with COVID management plans in place to protect our members and the community. Another COVID measure saw the Council Lifeguards on the beach on both Saturday and Sunday, with our patrol groups providing support and manpower as required. The strong proactive relationship between the two groups allowed for a seamless transition to this new method of operating, with our 10 patrol groups embracing the change.

Our patrol captains were once again a source of leadership and support for patrolling members. Their commitment to and management of lifesaving operations ensured coverage of the beach every weekend with the required number of patrolling members in attendance with the required skill sets. The naming of Patrol of the Year is always a highly anticipated announcement at the end of season awards. The competition is always strong, and this season was no exception. Patrol 3, led by Patrol Captain Adrian Parker, were awarded the honour for 2020-21. A small but dedicated group, who despite their relative youth still managed to bring a great deal of skill and experience to the beach at each patrol. They displayed a high level of enthusiasm for patrols, a commitment to continuous improvement in their fitness and skill sets and delivered a high level of preventions.

Special mention and thanks to those members who completed 100% of their patrol hours and in some cases attended well above their rostered hours - Laura Barnett, Jon Baker, Peter Brown, Neil Caddis, Peter Eden, John Humphries, Kesley Kernes, Mark Kirkpatrick, Toni O'Donoghue, and Earl Rennie. These members generously gave up their time and expertise to support their own and other patrol groups as required.

Our statistics across the season from 26th September 2020 to 25th April 2021, included the attendance of 30,161 people at Dixon Park beach during patrol hours. Patrolling members provided support and protection for the community for 2,726 hours, they undertook 291 preventative actions, attended to 26 first aid incidents and performed 9 rescues from the surf. Our patrols worked tirelessly to ensure the safety of the beach going public, with no fatalities occurring on our watch.

Hunter Branch undertook periodic patrol audits to provide feedback regarding patrol compliance with standard operating procedures and direct focus to any areas where additional effort was required. The audits also served as a means for the regular review of the quality and consistency of our patrol services.

While COVID provided a new series of challenges for our patrols, they proved they were more than equal to the task and displayed their commitment to the SLSA mission on the beach every weekend. Our patrolling members should be extremely proud of the contribution they have made in providing a safe and enjoyable coastal experience for the local community and visitors, and we hope they all return for the 2021-22 season.

Nippers is, at its heart, an activity about teaching, preparing, and training the next generation of great Australian surf lifesavers. It could not exist without the valued contributions of the Age Managers, Water Safety, and other parent and community volunteers who make it happen every week by sharing their knowledge with the Nippers and keeping them safe in their activities.

One of the focuses this year was getting our nippers in the water a lot more and improving their board, swim, and aquatic rescue skills. Thanks to some glorious weather conditions on our Sundays, we were able to make this happen regularly, getting the nippers in the water nearly every session, with their water skills improving out of sight as a result. Some of the board and swim action this season was nothing short of remarkable!

Of the many highlights of the season, one was certainly our Twilight Nippers session. An afternoon session of Nippers, followed by a sausage sizzle, jumping castle, and coldies at the Club gave the whole Nippers community a chance to get together, socialise, and increase community spirit within the club. We hope to schedule more of these sessions next season and bring the Nippers community together!

This year also saw the award of the inaugural Dale Laverty

Memorial Trophy. As many in the Club are aware, Dixon Park lost a very significant long-serving member in Dale Laverty in 2020. Dale's wife, Susan, kindly donated an annual trophy to our Nippers community, the Dale Laverty Memorial Trophy. The Dale Laverty Memorial Trophy celebrates the life of Dale and memorialises his passion for surf lifesaving and contribution to the Club, particularly his involvement with Nippers and his contribution to surf lifesaving in general. The Dale Laverty Memorial Trophy will be awarded to a Dixon Park Nipper each season who most strongly meets the following criteria:

- I. Contributes to Dixon Park SLSC and to SLS in general
- II. Displays teamwork skills
- III. Displays leadership and mentoring skills
- IV. Displays surf lifesaving knowledge and skills
- V. Respects Age Managers, Water Safety, and other Nippers

The inaugural winner of this trophy was our awesome U13 Nipper, **Kyle Burr.** Kyle has had an outstanding season at Dixon Park Nippers, and at every session he showcases his mentoring, leadership, teamwork, and surf life-saving skills, acting as a role model for our younger nippers. Well done, **Kyle!**

This season, to raise money for the club and our Nippers, we held weekly sausage sizzles, had regular merchandise sale days, and raffled a beautiful signed and framed 2020 Newcastle Knights jersey. Due to this, we raised several thousand dollars for the club, which goes directly to providing more equipment for our Nippers and, most importantly, saving lives.

Next season, the focus of Nippers will shift a little more towards competition. That is not to say that all Nippers must compete: we simply want to make sure that Nippers who do want to compete could do so. SURF SPORTS REPORT

The 2020-21 Surf Sports Season was ravaged by the COVID 19 and lots of rain.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

Corporate Information

The financial report is for the year ended 30 June 2021 for Dixon Park Surf Life Saving Club Inc. as an individual entity, incorporated and domiciled in Australia.

The financial statements were authorised for issue on 3 August 2021 by the officer bearers of the entity.

Financial Reporting Framework

The committee have prepared the financial statements on the basis that the entity is a non-reporting entity because there are no users dependent on general purpose financial statements. These financial statements are therefore special purpose financial statements that have been prepared in order to meet the requirements of the Australian Charities and Not for Profits Commission Act 2012. The entity is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

Statement of Compliance

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the Australian Charities and Not for Profits Commission Act 2012, being:

- AASB 101 Presentation of Financial Statements
- AASB 107 Statement of Cash Flows
- AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors
- AASB 1048 Interpretation of Standards
- AASB 1054 Australian Additional Disclosures

Basis of Preparation

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs unless otherwise stated in the notes. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless stated otherwise.

Accounting Policies

a. Revenue

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue

Operating grants, donations and bequests

When the entity receives operating grant revenue, donations or bequests, it assesses whether the contract is enforceable and has sufficiently specific performance obligations in accordance with AASB 15.

When both these conditions are satisfied, the entity:

- identifies each performance obligation relating to the grant
- recognises a contract liability for its obligations under the agreement
- recognises revenue as it satisfies its performance obligations.

a. Revenue (cont.)

Where the contract is not enforceable or does not have sufficiently specific performance obligations, the entity:

- recognises the asset received in accordance with the recognition requirements of other applicable accounting standards (eg, AASB 9, AASB 16, AASB 116 and AASB 138);
- recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer); and
- recognises income immediately in profit or loss as the difference between the initial carrying amount of the asset and the related amount.

If a contract liability is recognised as a related amount above, the entity recognises income in profit or loss when or as it satisfies its obligations under the contract

Capital grant

When the entity receives a capital grant, it recognises a liability for the excess of the initial carrying amount of the financial asset received over any related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer) recognised under other Australian Accounting Standards.

The entity recognises income in profit or loss when or as the entity satisfies its obligations under the terms of the grant.

Interest revenue is recognised using the effective interest method.

All revenue is stated net of the amount of goods and services tax (GST).

b. Property, Plant and Equipment (PPE)

Property improvements and plant & equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Property improvements are amortised over the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable assets are:

c. Impairment of Assets

At the end of each reporting period, the committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

d. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks and other short-term highly liquid investments with original maturities of three months or less.
